## **FUNDING ELIGIBILITY CRITERIA**

### **Applicant Eligibility**

- Organisational Status (please indicate)

- The applicant has the right to carry out this proposal/project
- Your project/proposal **MUST** be taking place in the state of Victoria, Australia.
- Your project/proposal must be starting in 2023 with a completion date stated (or ongoing if applicable).
- An acquittal report is required 4 months after project completion
- Projects that do not go ahead **MUST** return financial support in full

### **Funding Criteria**

Consistent with the aims of the OGV Annual Giving Program, charities or organisations that meet the following merit criteria are encouraged to apply

- The project must be a horticultural project
- The project should fall within the five arms of Giving, all related to horticulture:
  - Education
  - Wellness
  - Innovation
  - Community
  - Sustainability
- The project should meet one or more of OGV's objectives and be measurable:
  - To be connected to big issues – the environment, food, community and wellness
  - To be a respected voice within the gardening and horticultural community
  - To appeal to and reach a broad audience, breaking down barriers to gardening
  - To promote gardening as a valuable form of creative expression and an important part of our culture.
- The project should be community based
- Preference will be given to organisations/charities/individual projects that are Not for Profit
